**Description:** The New York Convention Center Operating Corporation (NYCCOC), a New York State public benefit corporation, is soliciting proposals from qualified vendors to provide 34<sup>th</sup> Street and 11<sup>th</sup> Avenue Security and Landscape Improvements services for the Jacob K. Javits Convention Center (Javits Center).

The project will include demolition of the existing sidewalks, curbs, parapet wall and roadway excavation; installation of structural supports for steel bollards and installation of operable vehicle raptors; re-building of new sidewalks, new concrete foundation, pavers and terrazzo installation; landscape improvements. The project will be built in three phases, as delineated in the drawings, over the period of 36 months. All labor, materials and required NYCDOT permits are to be included in the proposal. The proposal is to be broken down by three work phases as per drawings and specifications, and it should reflect pricing for planters, plantings, outdoor furniture, terrazzo, concrete sidewalks, pavers, bollards and operable vehicular barriers.

A site visit is scheduled for Thursday, December 6, 2018 at 11 a.m. (registration required).
